- * If your spouse is eligible to participate under another employer's medical plan and you elect to enroll them in the LII medical plan, you will pay an additional \$100 per month for their coverage.

Did You Know?

You can only change your benefits and covered dependents after enrollment if you have a qualified life event, such as a birth, adoption, or marriage. Changes must be made within 31 days of the event.



Remember to submit dependent eligibility verification documentation, such as a marriage license or birth certificate, directly to BenefitSource within 60 days of electing benefits. Your dependent's benefits will not be effective until documentation is received.

Care for your children under age 13 and elder care expenses for a dependent adult.

Plan Carefully

You can roll over up to \$550 of your Health Care FSA balance to 2023. Unused Dependent Day Care FSA funds will be forfeited after the deadline.

You have until December 31, 2022 to incur expenses, and you must submit expenses for reimbursement by March 31, 2023.
