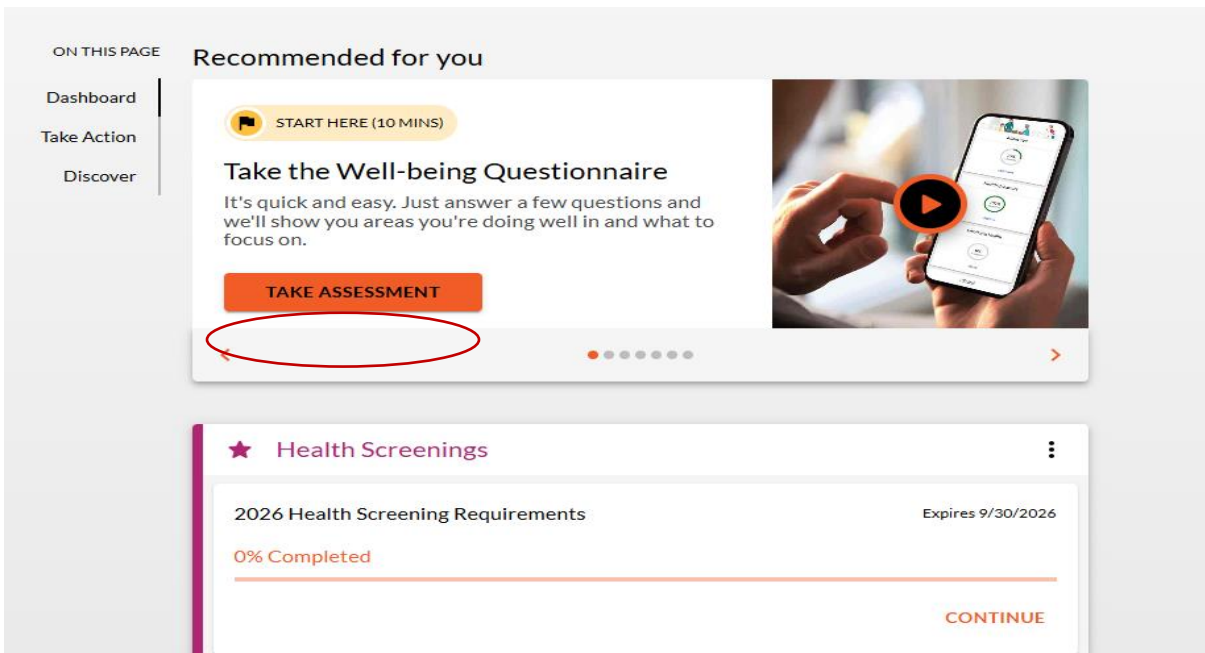


Q: How do I access forms? (Physician Form, LabCorp Form, Pregnancy Waiver or Medical Waiver)

2026 Health Screening Options for Employees and covered legal Spouses

To avoid the \$75 monthly wellness surcharge, all employees and their legal spouses enrolled in the Lennox medical plan must complete a health screening between January 1, 2026 and September 30, 2026. There are 3 ways to complete the health screening:

Option 1: On-Site Health Screening

Available at designated worksite locations. Appointment scheduler opens July 2026. Watch for more details closer to that date.

Option 2:

1. **Download** and print the Lennox LabCorp voucher and schedule your appointment at www.LabCorp.com
2. Choose a LabCorp location offering "Employee Wellness with Body Measurements."
3. Bring the following to your appointment:

- Printed voucher (page 2)
- Appointment confirmation number
- Photo ID

Option 3: Physician Visit

Download a Physician Form and bring the PRINTED form to your doctors appointment.

IMPORTANT - Your doctor must complete and sign the form using results from a visit between January 1 - September 30, 2026 .

Special Circumstances

Medical Waiver If your doctor advises against participation for medical reasons, or you did not pass the annual health screening, download and complete the Medical Waiver Form.

You must still submit a health screening by September 30, 2026 to validate the waiver.
